## Application:

### Other specific restrictions:

- (1) To avoid risks to human health & the environment comply with the terms of this approval in conjunction with the directions for use on the product label.
- (2) For any individual crop the maximum total dose refers to the total dose of any product containing the same active ingredient.
- (3) Application by tractor mounted/trailed sprayer only.
- (4) Post application, do not allow unprotected persons to enter treated areas until the crop is completely dry & has been well ventilated.

There is limited evidence of crop safety and/or product efficacy available for this extension of authorisation for minor uses and the commercial risk of using this product on the crops/situations listed in this document is borne entirely by the grower.

- (5) A maximum of 1 litre of product/ha may be applied to the same area of land every three years.
- (6) For environmental information refer to the product label but specifically: To protect aquatic organisms respect an unsprayed buffer zone of 5m to surface water bodies from tractor mounted/trailed sprayers. Aim spray away from water. Growers may be eligible to reduce the buffer zone under the PRCD STRIPE Scheme.
- (7) This approval extends to professional use only.
- (8) For operator protection refer to the product label in conjunction with the specific restrictions above.
- (9) Adverse effects: Approval holders must immediately submit any new information on the potentially dangerous effects of a product or residues of an active substance contained in a product, on human or animal health, or the environment.

## Advisory information:

This approval relates to the use of Venzar 500 SC as a horticultural herbicide for use on the crops, situations and control of the above mentioned broad leaf weeds. Lenacil is primarily a residual herbicide but does have some contact control on weed already present. The efficacy is reduced if the soil is very dry.

#### Resistance Management:

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical groups or alternative control measures should be included in the planned anti-resistance strategy. This product should be used in conjunction with other fungicides from different cross-resistant groups [different mode of action, HRAC group] with satisfactory efficacy against the target.

Venzar 500 SC contains lenacil

Lenacil is classed HRAC group: C1, Uracil herbicides.
