

EXTENSION OF AUTHORISATION FOR MINOR USES (EAMU)

INSTRUCTIONS FOR USE

PPP: DEVBINOL (PCS No. 05234)

CROPS:

Outdoor grown crops of: celeriac, horseradish, swede, turnip, Chinese cabbage, choy sum, collards, borage, evening primrose, linseed, mustard (all grown for oilseed).

Protected and outdoor crops of: baby leaf, lamb's lettuce, rocket, red mustard, spinach, and herbs.

For this EAMU the following crop definitions apply:

Baby leaf production includes: salad and brassica leaves up to 8 true leaves.

Herbs includes: Angelica, basil, bay, borage, caraway leaves, celery leaves, chervil, coriander leaves, curry plant, dill leaves, edible flowers, fennel leaves, lemon grass, lovage, marjoram, mint, oregano, parsley, peppermint, rosemary, sage, savory (winter and summer), sweet cicely, tarragon, thyme.

This approval provides for the use of the product **DEVBINOL (PCS No. 05234)** in respect of, the crops and situations as listed above, which are extra to those specified on the product label.

The conditions of application outlined below are statutory. They must be complied with when availing of this extension for minor uses.

The instructions provided in this extension for minor uses must be used in conjunction with information provided on the approved product label.

Failure to abide by the conditions of approval specified below or on the product label may constitute a breach of the product approval.

Other specific restrictions:

- (1) To avoid risks to human health & the environment comply with the terms of this approval in conjunction with the directions for use on the product label.
- (2) For any individual crop the maximum total dose refers to the total dose of any product containing the same active ingredient.
- (3) Application should be made in 200-400 l water per ha.
- (4) Post application no unprotected person should enter the treated area until the application had dried & the area has been well ventilated.
- (5) This approval extends to professional use only.
- (6) Application may be made via tractor mounted/trailed sprayer only.
- (7) For environmental information refer to the product label and specifically: To protect aquatic organisms respect an unsprayed buffer zone of 5m to surface water bodies from tractor mounted/trailed sprayers. Direct spray away from water.
- (8) For operator protection refer to the product label in conjunction with the specific restrictions above.

- (9) Adverse effects: Approval holders must immediately submit any new information on the potentially dangerous effects of a product or residues of an active substance contained in a product, on human or animal health, or the environment.

Advisory information:

This approval relates to the use of DEVIRINOL as a horticultural herbicide for use on the crops and in the situations listed above. Due to the range of crops on this off label & the numerous different varieties growers are advised to test a small area of the crop first to ensure application will not cause damage to the crop especially if the crop is under any stress.

Anti-resistance Strategy:

This product should be applied in accordance with an anti-resistance strategy. Weed control may be reduced if resistant strains develop. It is recommended that this product is used in an alternating programme with different modes of action (HRAC group) & also with efficacy against the target. DEVIRINOL contains Napropamide which is classed HRAC group K3 (acetamides).

IMPORTANT PLEASE NOTE:

Prior to the use of this product, growers should take advice from their crop advisors particularly in relation to the use of this product within an integrated crop management system of production.
