RESTRICTIONS

Professional use only

DO NOT apply before heavy rainfall, which may reduce the persistence of granules. Late application of pellets to broad-leaved plants may result in lodging of the pellets in foliage. Care should be taken to avoid this during application in edible crops.

Keep dogs out of the field during application. When the applicator stops/starts, ensure no small heaps of pellets are left on the soil surface as they may be consumed by dogs and other animals. Spillages must be buried or removed.

APPLICATION RECOMMENDATIONS

Best results are achieved when application is made during mild, damp weather when slugs are the most active. When slug attack is heavy or prolonged, repeat treatments may be required.

All crops

7 kg/ha broadcast evenly over soil or standing crop using any suitable slug pellet applicator. For crops to be drilled best results are from application a few days before drilling. Alternatively, apply just before or just after drilling. For emerged or established crops, apply immediately damage appears.

Do not apply more than three times per season (maximum of 21 kg/ha)

Minimum interval between applications 7days

COMPANY ADVISORY INFORMATION

Slug pellets are pesticides, keep pesticides out of water

• Pellets should not fall within 5m of the top of the bank of a watercourse or ditch. To achieve this, users should determine the spread width of the applicator with the product to be applied prior to any application (to the rear as well as the side of the applicator).

• Calibrate your applicator before use

• Fill and clean application equipment in the field

• Do not fill or clean down in the yard

• Avoid applying slug pellets when heavy rain is forecast

• Check that product packaging is intact and clear up spillages immediately
